. Applicants are seeking withdrawal of the amount deposited by the respondent-acquiring body. These matters pertain to acquisition of the land for the construction of the railway track from Nagar-Beed-Parali. In the similarly situated matters, this Court already permitted the claimants to receive the amount deposited with accrued interest on furnishing undertaking. Few such orders are placed on record. I propose to follow the same course.

2. Civil Applications are allowed permitting the applicants to receive the amount deposited with accrued interest on furnishing undertaking to the satisfaction of the learned Registrar (Judicial).
