PER COURT :-

1. Heard the respective parties.
2. Applicants are seeking condonation of delay, for the reasons stated in the applications.
3. Learned respective counsels for acquiring body and learned AGPs for respondents/State would vehemently oppose the applications. My attention is adverted to the order passed by the Co-ordinate Bench dated 02.05.2025 condoning the

delay. Present appeals also arising out of same acquisition proceeding. I propose to follow the same course. Applicants shall not be entitled to interest and statutory benefits for the delay. Therefore, I pass following order :

ORDER

- (i) Civil applications for delay are allowed.
- (ii) Delay caused in filing appeals are hereby condoned, subject to condition that applicants file undertaking to the Registrar (Judicial) of this Court stating that they shall not claim interest and statutory benefits for the delayed period on enhanced compensation, in case, their appeals are favourably considered. Such undertaking to be filed within a period of ten (10) weeks from today and shall be made part of the compilation.

In First Appeals

4. **Admit.**

5. Learned AGPs waive service of notice for the respondents/State Authorities. Learned counsels Mr. Usmanpurkar and Mr. Mahajan waive service of notice for Respondent No.3 in respective matters.

6. Call for Record and Proceedings from the concerned Court.
