NO. 1429 OF 2025**

1. The appellant/acquiring body has filed Civil Application No.1430 of 2025 for setting aside order dated 09.02.2024 in the main appeal whereby the said appeal was dismissed against deceased respondent No.1A – Vivek Yashwantrao Dange who died on
