- (iv) Remaining amount be kept in fixed deposit in any nationalized bank till final disposal of the first appeal.
- (v) With this, civil applications stand disposed off.

6. Since the applicants have deposited the entire amount of compensation in the office of this Court as per impugned judgment and award, there shall be stay to the execution of the judgment and award

till final disposal of the first appeal.
