ORDER:-

1. As per the request of learned Counsel for the appellants/claimants, First Appeal No. 756 of 2022 filed by the claimants and the corresponding First Appeal (St) No. 23256 of 2020 alongwith civil applications are detagged from the group of these appeals.

2. Heard rival submissions.

3. All these appeals are filed by the respective claimants for enhancement of compensation. The Acquiring Body has also filed certain appeals challenging some of the impugned awards in the appeals filed by the claimants. However, during the pendency the learned Counsel for the appellants/claimants placed reliance on the judgment passed by the learned Reference Court in the group of LAR No. 274 of 2012 and others whereby the learned Reference Court in those matters has granted following rates for calculation of compensation in respect of the lands as well as fruit bearing and forest trees.

1. For Bagayat Land - Rs. 10,00,000/- per Hectare
2. For Jirayat Land - Rs. 5,00,000/- per Hectare
3. For Potkharab Land - Rs. 2,50,000/- per Hectare
4. For forest trees - 60% of the amount mentioned in the valuer's report
5. For fruit bearing trees - 80% of the amount mentioned in the valuer's report

It is to be noted that the same valuer's report in respect of forest and fruit bearing trees is also considered in all these appeals filed by the appellants/claimants.

4. The learned Counsel for the appellants/claimants therefore submits that the compensation at the same rates be awarded in the present appeals also. The respective learned Counsel for the Acquiring Body also accepted the said position as they have already settled some other matters by granting the same rate as mentioned above. However, the respective learned Counsel for the Acquiring Body submit that the land beneath the fruit bearing and forest trees needs to be deducted while computing the compensation in respect of the lands mentioned in these appeals. The learned Counsel for the appellants has pointed out that such deduction is already

made by the learned Reference Court in all these appeals. Therefore, there is no question of giving separate direction to the executing court while computing the amount of compensation as per the rates mentioned above.

5. In view of the same, all the first appeals (except detagged appeals) filed by the appellants / claimants for enhancement of compensation are allowed in terms of the judgment dated 12.04.2018 in group of LAR No.274 of 2012 and others and the rates mentioned in aforesaid para No.3 are granted for calculating the compensation amounts in each of these appeals. The awards be prepared in all these appeals according to the aforesaid rates and be modified accordingly. However, the rate of interest which is to be awarded under Sections 28 and 34 of the Land Acquisition Act be calculated from the date of award only. The other statutory benefits granted by the Reference Court be kept as it is. The enhanced amounts of compensation so calculated be deposited by the Acquiring Body within six months. After deposit of such amounts of enhanced compensation, the concerned appellants/claimants are entitled to withdraw the same alongwith the interest without further reference to this Court.

6. The appeals filed by appellants/claimants (except detagged appeals) are accordingly disposed of alongwith pending civil applications, if any. Needless to say, the appeals filed by the Acquiring Body against some of the impugned judgments are also disposed of alongwith the pending civil applications, if any.
