1. Heard rival submissions.
2. The applicants in all these applications are seeking condonation of delay periods mentioned therein. The delay appears to be caused due to their poor financial condition. The learned counsel for the respondent Acquiring Body and the learned AGP strongly opposed the application on the ground that the delay is not properly explained.
