PER COURT :-

1. Heard both sides.
2. Civil applications for withdrawal of amount can be decided by common order because applicants are seeking disbursement of the amount deposited in this Court by the respondent/acquiring body.
3. Following is the breakup of the relevant facts.

4. Learned counsel for the respondent and learned AGP would oppose the application as well as submissions of the learned counsel for the applicants.

5. I have considered rival submissions of the parties. The respondent/acquiring body has deposited amount in this Court as shown in the aforesaid table. Ends of the justice would be made in permitting the applicants to receive the amount deposited in this Court by imposing certain conditions.

6. Civil applications for withdrawal of amount are partly allowed permitting the applicants to receive 75% of the amount with accrued interest on furnishing undertaking and further balance 25% on furnishing solvent surety/security to the satisfaction of the Registrar (Judicial) of this Court.

Civil Applications for Delay

7. For the reasons stated in the applications, delay stands condoned. Civil applications for delay are allowed.

9. Learned counsel Mr. Shinde waives service of notice for respondents/claimants.

10. Call for Record and Proceedings from the concerned Court if not called for.

Civil Applications for Stay

11. In pursuance of the orders, respondent has deposited the amount, therefore, ad-interim relief granted earlier shall stand confirmed.

12. Civil applications for stay are disposed of.
