- . These are the Applications by the Acquiring Body for stay to the impugned Judgment and Award.
2. This Court by order dated 14.12.2020 has granted ad interim stay to the impugned Judgment and Award subject to deposit of 60% amount under the Award. There is no dispute that the Acquiring Body has deposited 60% amount as directed by this Court.
