ORDER

Further 25% of the amount is allowed to be withdrawn along with accrued interest on furnishing solvent surety/security to the satisfaction of the learned Registrar (Judicial) of this Court. Balance amount be kept in a fixed deposit in any Nationalized Bank to be renewed from time to time till disposal of the appeals.
