2. None appears for the respondent-acquiring body though served.
3. The applicants seek to condone delay ranging from 747 days to 2247 days.
4. The learned counsel for the applicants submits that there are lapses on the part of the applicant in circulating the appeals. The applicants are ready to forgo interest and the statutory benefits for the delayed period.
5. Learned A.G.P. opposes the applications.
6. The averments in the applications have not been controverted. There are no *mala fides* on the part of the applicants in preferring the appeals belatedly. It is desirable to condone the delay.
7. The Civil Applications are allowed and delay stands condoned on condition that applicants shall not be entitled to claim interest and statutory benefits for the delayed period.
