. Learned Counsel Mr. B. K. Pawar h/f Mr. A. B. Kale,
learned Counsel for appellant places on record an order dated
01.08.2025, passed by learned Division Bench of this Court in

2. Learned Counsel for the appellant further submits that these matters also arise out of the same award. 4. Learned Counsel for the appellants also assures that he shall remove the rest office objections within four weeks from today. Subject to this, First Appeals are restored.

5. As observed in the orders (supra) objection of delay in

filing the First Appeal is waived. Subject to above, the registration of First Appeals is restored.
