CIVIL APPLICATION NO. 7218 OF 2025

1. The applicants seek permission to bring on record legal representatives of deceased applicant no.1-Gangadhar Ramrao Gadhwe. Mr. Nagarkar, learned counsel for the applicants submits that pursuant to the order dated 17th July 2025, the costs imposed by this Court have been paid, amendment has also been prepared and the same is on

record. As such, he prays to allow the Civil Application.

2. Mr. S. S. Dande, learned AGP requests to pass appropriate order.

3. In these circumstances, I pass the following order :-
