PER COURT :-

1. Today, the learned advocates Ms. Sunita D. Shelke and Mr. Rahul A. Tambe, have moved these matters in chamber for modification of order dated 16.01.2025, more particularly, paragraph Nos. 10 and 11 thereof. It has been pointed out that the last sentence of para 10 of the said order is wrongly typed as "*In view of the said statement, the applications are disposed of as infructuous*" instead "In view of the said statement, the stay granted earlier stands confirmed till disposal of the first appeals. Civil applications are disposed of."

2. In the light of above, last sentence of para 10 of the said order dated 16.01.2025, shall read as "**In view of the said statement, the stay granted earlier stands confirmed till disposal of the first appeals. Civil applications are disposed of.**"

3. In so far as para Nos. 11 and 12 are concerned, they are modified as under:-

"11. In so far as Civil Application Nos.1131, 1135, 1137, 1133, 1165 and 1163 of 2021, filed for condonation of delay are concerned, heard learned advocates for both the parties. For the reasons stated in the said applications, the same are allowed. Delay caused in filing

the first appeals stands condoned.

4. In so far as civil application Nos. 1132, 1136, 1138, 1134, 1166 and 1164 of 2021 which were filed for granting stay to the impugned judgment and award are concerned, learned advocate Mr. Tambe, makes a statement that entire amount as directed by this Court vide order dated 25.1.2021 has been deposited and out of the said amount, 75% of the amount has already been withdrawn by the original claimants. In view of the said statement, the interim stay granted to the execution of the impugned judgment and award shall operate till the disposal of the respective first appeals.

5. The paragraph Nos. 10, 11 and 12 of the order dated 16.01.2025 stand modified and corrected to the above extent only.
