. All the First Appeals are filed by the Acquiring Body, challenging enhancement granted by the learned Reference Court in the respective Land Acquisition References as mentioned below:

2. Pursuant to the interim relief granted in favour of the Acquiring Body in their Civil Applications, the Acquiring Body has deposited the entire amount in this Court. As such, there is compliance of the first order passed by this Court. Pursuant to the deposits made by the Acquiring Body, present Civil Applications are moved by the claimants for withdrawal of the

deposited amount.

3. Mr. D. M. Pingale, learned Advocate for claimants submits that the entire source of livelihood of the claimants have been acquired by the Acquiring Body. Although, they have meager entitlement for compensation, their entitlement has been rightly adjudicated by the learned Reference Court. The Acquiring Body has unnecessarily challenged those in the appeals whereby, they are deprived of their legitimate right to get the compensation to which they deserve. With this, he seeks withdrawal of the entire amount granted by the learned Reference Court.

4. Per contra, Mr. S. S. Dande, learned AGP, appearing for the Acquiring Body vehemently opposes the Civil Applications atleast to the extent of 50 percent of the deposited amount. Mr. S. S. Dande would further submit that the enhancement granted by the learned Reference Court is 20 times more than the enhancement granted by the Competent Authority. He submits that the acquiring Body has good hopes of success in the First Appeals. He would further submits that interest of the claimants is well protected since the amount is deposited in this Court. Mr. Dande further demonstrates his

apprehension that if the entire amount is allowed to be withdrawn to the claimants, the public fund would be at danger if in the event his First Appeals stand allowed, as there is possibility that the Acquiring Body would be in difficulty to recover the amount exorbitantly granted by the learned Reference Court.

5. In view of the above consideration, I pass following order:

ORDER

- a. Civil Applications stand partly allowed.
- b. The applicants are permitted to withdraw 50 percent of the deposited amount on furnishing usual undertaking to the satisfaction of the learned Registrar (Judicial) of this Court.
- c. Balance amount, if any, be deposited in the fixed deposit in any nationalized bank.
