1. These applications are for withdrawal of the amount deposited by the appellant – acquiring body in the office of this Court.

2. The learned advocate for the applicants relies upon the order dated 30.09.2022 in Civil Application No. 15259/2019 in First Appeal (Stamp) No. 8995/2017 passed in similar matter arising out of the same acquisition proceedings .

3. Considering the above, following order :

**ORDER**

(I) The applicants are permitted to withdraw 50% of the amount deposited in the office of this Court alongwith accrued interest on furnishing usual undertaking. Further 25% of the amount alongwith accrued interest is allowed to be withdrawn on furnishing solvent surety/security to the satisfaction of the learned Registrar (Judicial) of this Court. Remaining amount be kept in a fixed deposit in any Nationalized Bank till disposal of the appeal.

(II) With this, civil applications stand disposed of.
