1. This motion is moved for speaking to minutes of the Judgment and order dated 27-11-2025.

2. Mr.Autade, learned counsel for respondent no.1 submits that, in this matter, he appeared only on behalf of respondent no.1, however, inadvertently in title clause and in paragraph 7 of the Judgment, his appearance is shown for respondent nos.1 and 2. He further submits that inadvertently respondent no.3/owner, is not included in the title clause of Judgment. He further submits that respondent no.1/claimant may be permitted to withdraw the amount lying in this Court along with interest as directed by learned Tribunal.

3.
