CIVIL APPLICATION NO. 10819 OF 2025

. This is an application for withdrawal of amount under impugned judgment and award deposited with this Court.

2. Perused the application. Heard learned Advocates for both the sides.

3. Learned Advocate for the respondent no.1 strongly opposed the application and prayed to reject the same.

4. Considering the reasons stated in the application and fact situation of the case, it would be proper to partly allow the application. Hence, following order:

ORDER

- a. Civil Application is partly allowed.
- b. Applicants are permitted to withdraw 75 percent amount out of deposited amount alongwith interest accrued thereon by furnishing usual undertaking to the satisfaction of the learned Registrar (Judicial) of this Court.
