2. Applicants are seeking condonation of delay in preferring first appeals. Following are the material particulars :

3. Learned counsel for the applicants submits that for the reasons stated in the applications, delay deserves to be condoned. There are no mala-fides on part of the applicants. Applicants are ready to give up interest and statutory benefits for the delayed period.

4. Applications are contested by learned AGP. It is submitted that there are no convincing grounds for condonation of delay. Applicants are not entitled to interest for the delayed period as well as period

covering the lapses.

5. I have considered rival submissions of the parties. The averments in the applications are not specifically traversed by the respondents. No mala-fides can be inferred from the applications. The applicants are ready to give up interest and statutory benefits for the delayed period. They are also not entitled to interest and the statutory benefits for 50% for period of lapses.

6. Civil applications are allowed and the delay stands condoned on condition that applicants shall not be entitled to interest and statutory benefits for the delayed period as well as 50% for period of lapses i.e from date of filing of application to date of securing first order as disclosed in the aforementioned paragraph.
