CIVIL APPLICATION NO. 12781 OF 2025

. Applicants are seeking withdrawal of the amount deposited by the respondent-acquiring body. This matter pertains to acquisition of the land for the construction of the railway track from Nagar-Beed-Parali. In the similarly situated matters, this Court already permitted the claimants to receive the amount deposited with accrued interest on furnishing undertaking. Few such orders are placed on record. I propose to follow the same course.

2. Civil Application is allowed permitting the applicants to receive the amount deposited with accrued interest on furnishing undertaking to the satisfaction of the learned Registrar (Judicial).

CIVIL APPLICATION NO. 3520 OF 2025

. The acquiring body seeks to condone the delay of 336 days in preferring the appeal for the reasons stated in the application.

2. I do not see any malafides on the part of the acquiring body in preferring the appeal belatedly. Many such appeals were filed by the acquiring body and the delay was condoned. I propose to adopt the same course.

3. Civil Application is allowed. The delay stands condoned.

FIRST APPEAL

- . **Admit.**
2. Mr. S. E. Shekade, learned counsel waives service of notice for respondent nos.1 and 2.
3. Call Record and Proceeding. Print is dispensed with.
4. An endeavor shall be made to decide the present appeal finally.

CIVIL APPLICATION NO. 3521 OF 2025

- . As the entire amount is deposited by the acquiring body, stay granted earlier shall stand confirmed.
2. Civil Application is disposed of.
