PER COURT:

1] Heard learned counsel for the applicant and the learned APP for the respondent-State.

2] The applicant is apprehending arrest in connection with Crime No.509/2024, dated 15.10.2024, registered at Cantonment (Chhavani) Police Station, District Aurangabad, for the offences punishable under sections 352, 351(3), 351(2), 191(3), 191(2), 190, 189(4), 189(2), 109 of B.N.S. 2023.

3] The learned counsel for the applicants, on instructions, seeks leave to withdraw the application for applicants no.1, 2 and 3.

4] Leave granted.

5] As regards applicants no.4 and 5 are concerned, the allegations are general in nature. There is no specific role of assault by them. Considering the same, the application is allowed qua applicants no.4 and 5.

6] In view of the above, the application is allowed qua applicants no.4 and 5 in the following terms :

i] In the event applicants no.4 and 5 are arrested in connection with Crime No.509/2024, dated 15.10.2024, registered at Cantonment (Chhavani) Police Station, District Aurangabad, for the offences punishable under sections 352, 351(3), 351(2), 191(3), 191(2), 190, 189(4), 189(2), 109 of B.N.S. 2023, they shall be released on bail on furnishing PR bond of Rs.15,000/- each with one or two sureties in the like amount to the satisfaction of the trial Court.

ii] Applicants no.4 and 5 shall attend the police station as and when required by the Investigating Officer.

iii] Applicants no.4 and 5 shall not tamper with the evidence of the prosecution in any manner. They shall not influence the informant, witnesses and other persons concerned with the case.

iv] Applicants no.4 and 5 shall co-operate with the investigation and also in the proceedings before the trial Court.

7] In the event, applicants no.4 and 5 violates any of the conditions specified in this order, it shall be liable to be cancelled.

8] It is also clarified that the observations made in this order are limited to the disposal of the present anticipatory bail application and the trial Court shall proceed further in the matter without being influenced by the observations made hereinabove.

9] The application stands disposed of.
