PER COURT:

1] Heard learned counsel for the applicants and the learned  
APP for the respondent-State.

2] The applicants are apprehending arrest in connection with  
Crime No.362/2023, registered at Satara Police Station, District  
Aurangabad, for the offences punishable under Sections 326, 324, 504,  
506, 323 and 34 of I.P.C.

3] This court by interim order dated 08.12.2023 protected the applicant no.3 and, thereafter, by interim order dated 07.02.2024, protected all the applicants.

4] The learned counsel for the applicants submits that the parties have settled their dispute, so also, they have cooperated with the investigation and the charge-sheet is also filed in the matter.

5] Considering the nature of allegations and the settlement between the parties, no further custodial interrogation would be necessary. The interim protection granted earlier would stand confirmed.

6] In view of the above, the interim protection granted by orders dated 08.12.2023 and 07.02.2024 stands confirmed, on the following terms:

i] The applicants shall not tamper with the evidence of the prosecution in any manner. They shall not influence the informant, witnesses and other persons concerned with the case.

ii] The applicants shall co-operate in the proceedings before the trial Court.

7] In the event, the applicants violate any of the conditions specified in this order, it shall be liable to be cancelled.

8] It is also clarified that the observations made in this order are limited to the disposal of the present anticipatory bail application

and the trial Court shall proceed further in the matter without being influenced by the observations made hereinabove.

9]           The Anticipatory Bail Application stands disposed of.

10]           In view of disposal of the anticipatory bail application, Criminal Application No.16 of 2024 for assist to public prosecutor is also disposed of.
