PER COURT :

1. Petitioners have submitted their undertaking before this Court. Petitioners shall submit the same before the Deputy Director of Education.

2. Learned advocate for petitioners submits that Writ Petition No.3530/2018 and connected matters of similarly situated Assistant Lecturers who had approached to the Coordinate Bench of this Court at Principal Seat for directions, was allowed by order dated 13/09/2021 passed by the Coordinate Bench of this Court at Principal Seat [Coram : R. D. Dhanuka and Abhay Ahuja, JJ.] and it was directed to the State Government to grant approval to the appointment of petitioners therein who were parties to the consent terms. He, further submits that the petitioners herein were persons

appointed pursuant to the consent terms and therefore, they are entitled for the same relief.

3. We cannot go into the merits in contempt jurisdiction. In the peculiar facts of the case, we direct the petitioners to submit undertaking before the Deputy Director of Education and appear before him on 06/01/2026. The Deputy Director shall after hearing the petitioners and by taking into consideration the order passed by the Coordinate Bench of this Court at Principal Seat in the cases of similarly situated petitioners, take appropriate decision in the cases of petitioners within four weeks thereafter.

4. With these directions the contempt petitions are disposed of. Failure to follow the time stipulation mentioned above shall be treated as aggravated form of contempt.
