PER COURT :-

1. By order dated 26.02.2025, this Court had permitted amendment to be carried out in prayer clause (B) in Writ Petition

Nos.3489/2015, 6315/2018, 4125/2015, 4145/2015 and 4130/2015. It appears the amendment could not be carried out.
