1. Heard Ld. Counsel for the parties.
2. Ld. Counsel for the applicant would draw attention of the Court to the order dated 14 October 2024 in Anticipatory Bail Application No. 1738 of 2024 and order dated 13 December 2024 in Anticipatory Bail Application No. 2067 of 2024. By the said orders, *ad-interim* protection has been extended in favour of applicants which continues as on date. Ld. APP and Ld.
