Mr. Manurkar, the learned Advocate for the appellant states that in identical matters, i.e. Arbitration Appeal No.16 of 2024 and other connected appeals, this Court has vide order dated 22.10.2024, granted stay to the execution of the impugned award on the condition that the appellant deposits 50 percent of the amount of compensation as determined by the Arbitral Tribunal.

2. In view of the above, execution of the impugned award is stayed, subject to condition that the appellant deposits 50 percent of the amount of compensation as determined by the Arbitral Tribunal alongwith interest accrued before the returnable date.
