1. By this application, the Applicant is seeking relaxation of condition Nos.(b) and (d) imposed by this Court (Coram: Madhav J. Jamdar, J.) vide order dated 12th April, 2024.

2. By the said order, this Court has imposed condition on the Applicant that the Applicant shall not enter the Khatav-Taluka, District-Satara after being released on bail, except for reporting to the Investigating Officer, if called, and for attending the trial, and the Applicant shall report to Rahimatpur police station, Taluka-

Koregaon, District-Satara once every week, on every Sunday between 11:00 a.m. and 1:00 pm. till the conclusion of the trial. Learned counsel further submitted that the Applicant and his family stays in Khatav-Taluka. He has been released on bail on 12th April 2024, but since then, he has been unable to meet his family members due to above conditions. Investigation is completed and charge sheet has been filed. The Applicant is attending the Court's date regularly. Hence, requested to allow the application.

3. Learned APP strongly objected to allow the application on the ground that the Applicant has been charged under Sections 302, 324, 341, 143, 147, 148 and 149 of the Indian Penal Code, 1860 and he has played major role in the said crime. If he allows to enter in the Khatav-Taluka, he may commit further crime and he may threaten the prosecution witnesses as they are from Khatav Taluka. Hence, requested to reject the application.

4. I have heard both learned counsel. The Applicant stays at Khatav-Taluka. He has to look after his family. Investigation is completed and charge sheet has been filed. Considering these facts, I pass following order:-

ORDER

- i. The application is allowed.
 - ii. The Condition Nos.(b) & (d) imposed by this Court
(Coram : Madhav J. Jamdar, J.), are hereby relaxed.
 - iii. The Applicant shall attend the concerned police
station as and when required by the Investigating
Officer.
 - iv. The Applicant shall not contact the first informant
and prosecution witnesses.
5. In view of the above, the application stands disposed of.
