1. The present Application filed by the Original Claimants seeking permission to withdraw the entire compensation amount deposited by the Appellants. The matter is settled between the parties. Learned Counsel for the parties state that the parties have agreed to settle this matter at Rs. 5,35,000/- towards full and final settlement, but the Consent Terms are yet not prepared.
