1. Heard Mr. Kamat, learned Senior Advocate for Petitioner; Ms. Yewale, learned Advocate for Respondent No.1; Ms. Gavhane, learned AGP for Respondent Nos.2 and 7 and Mr. Kekane, learned Advocate for Respondent No.3.

2. Today when the matter is part-heard and listed before me, Advocate for Respondent – Society is not present.

3. Ms. Yewale informs the Court that she is unwell and when the matter is proposed to be kept tomorrow or day after tomorrow, she informs the Court to adjourn the matter by two weeks.

4. Such impression given to the Court primarily shows that

Respondent – Society is avoiding to argue further.

5. The Writ Petition is partly heard. I have finished hearing Mr. Kamat and the supporting Respondent Mr. Thorat on the last occasion and Advocate for Society had already almost finished her submissions, when this Court had asked and posed several questions to the Society which could not be answered.
