Heard learned counsel for the appellants. Issue notice to the respondents, returnable on 20/08/2019

2. *The present Appeal involves the following substantial question of law :*

“When the evidence on record indicates that the other members of the joint family were not residing as joint family and having their own source of income, whether the Courts bellow committed an error in arriving at the finding that the agricultural lands are purchased out of joint family funds ?

2. Substantial question of law is already framed. The second appeal is therefore admitted on the aforesaid questions of law.
3. Service is waived on behalf of respondent nos. 1 to 44.

Interim Application No. 3889 of 2022

10. Issue notice to respondent nos. 17E(1) to 17E(3) returnable on 11th July 2025.

11. In addition to the court notice, learned Advocate for the appellants to serve respondent nos. 17E(1) to 17E(3) by private service and file service affidavit before the next date.

Issue Application No. 3822 of 2025

12. Issue notice to respondent nos. 20/1 to 20/4 returnable on 11th July 2025.

13. In addition to the court notice, learned Advocate for the appellants to serve respondent nos. 20/1 to 20/4 by private service and file service affidavit before the next date.

Civil Application No. 1579 of 2018

14. Rule on interim relief in terms of prayer clause (a) is made returnable on 11th July 2025.

15. Learned Advocate for respondent nos. 1 to 44 waives notice.

16. In addition to the court notice, learned Advocate for the appellants to serve the remaining respondents by private service and file service affidavit before the next date.
