. Learned Advocate for the Applicant at the outset, seeks leave to correct the pleadings in the Application. Leave granted. Amendment to be carried out forthwith.

2) Heard learned Advocates for the parties.

- 3) Present Application filed by the Applicant-claimant seeking permission to withdraw the compensation amount along with accrued interest.
- 4) Learned Advocate for the Appellant opposed the Application.
- 5) The Applicant-claimant is the widow. She needs the money for day-to-day and medical expenses etc.
- 6) In view thereof and considering the reasons stated in the Application, the Applicant is permitted to withdraw 50% of the compensation amount along with proportionate interest subject to furnishing an undertaking that in case the Appellant succeeds in this Appeal, the Applicant would refund the said amount along with interest as would be directed by this Court. The Tribunal shall invest remaining amount with Nationalised bank giving highest interest from time to time.
- 7) Application is disposed of accordingly.
