1. We are informed by both the parties that the issue involved in the above Writ Petition is pending before this Court in several other Writ Petitions and those matters have been fixed on 10th June 2025 under the caption 'for directions'.

2. It is also pointed out that in all those matters, interim and/or ad-interim relief has been granted. The prayer, therefore, today, is that the above Writ Petition also be tagged along with those Writ Petitions and be kept on 10th June 2025 ‘for directions’ and in the meanwhile, ad-interim relief be granted in terms of prayer clause e(i) and e(iii) of the Petition.

3. Having heard the learned counsel for the parties, and considering that the issue involved in the present Writ Petition is pending in several other Writ Petitions, we direct that the above Writ Petition be tagged along with Writ Petition No.465 of 2021 and other connected Writ Petitions and be kept on board ‘for directions’ on 10th June 2025.

4. In the meanwhile, and without prejudice to the rights and contentions of the Respondents, there will be ad-interim relief in terms of prayer clause e(i) and e(iii) which reads thus:

“i. stay the operation of the Impugned Notice dated 11th December 2024 (Exhibit “L”) issued by Dy.Commissioner of Respondent No.2.

iii. direct the Respondents to refrain from initiating any further proceedings including but not limited to a show cause notice with respect to recovery of any interest or penalty, or any other amounts in furtherance to the impugned Notice dated 11th December 2024 (Exhibit “L”) issued by Respondent No.3.”

5. Stand over to 10th June 2025 'for directions'.
