1. Heard learned counsel for the parties.
2. In all these matters, the Petitioners contend that they have not been paid the statutory benefits like solatium and interest in terms of the law laid down by the Hon'ble Supreme Court in the case of ***Union of India Vs Tarsem Singh and Ors.***¹.
3. The learned counsel for the Respondent-State and Highway Authorities have no objections to complying with the law laid down in *Tarsem Singh (supra)* and pay the Petitioners the statutory dues, if the same have not been already been paid and further if, the Petitioners are eligible to receive the same.
4. Mr. Sagar Varma, learned counsel for Highway Authorities raise some objections with regard to some of the Petitioners by

submitting that the decision in *Tarsem Singh (supra)* would apply only to acquisition after 2015.

5. At this stage, we are not going into such issues. All that we direct is that the Petitioners must be paid the statutory benefits of solatium and interest in terms of the law laid down in *Tarsem Singh (supra)* if they have not already been paid such benefits and if they are found to be eligible to receive such benefits.

6. The above exercise must be completed within three months of the uploading of this order.

7. The Petitions are disposed of in the above terms without any cost order. All concerned to act on an authenticated copy of this order.
