DRAFT MINUTES OF ORDER

1. The parties have amicably settled their disputes and have executed and filed Consent Terms in the Parsi Chief Matrimonial Court at Bombay in Parsi Suit No. 20 of 2022.
2. Accordingly, the following order is passed by consent of both parties.
3. By consent of parties- (i) Order dated 7 September 2022 passed in Suit No. 335 of 2022 (now re-numbered as Petition B-28 of 2025 before the Family Court at Bandra), which inter alia directed a *status quo* on Charles Schwab & Co. Account numbers 1982-3198 and 2893-4847; and (ii) Order dated 3 June

2025 passed by the Family Court at Bandra in Exhibits 12 and 39 of Petition B-28 of 2025, are set aside.

4. The Parties have executed and issued a notarised joint instruction letter addressed to M/s Charles Schwab & Co. Inc, United States of America ("Schwab") by way of Email with irrevocable instructions inter alia for- (a) the unconditional re-transfer of assets (*in specie* in USD) and cash as set out in the email dated 18 December 2025 to Schwab; (b) for de-linking Niloufer Soli Lam's sole Schwab Account 2893-4847 from the Schwab Account 1982-3198; (c) for removal of Niloufer Soli Lam's name as a joint tenant from the Schwab Account 1982-3198; (d) for unfreezing of both accounts i.e., Account Number 1982-3198 and Account Number 2893-4847; and (e) for neither Party to instruct Schwab in relation to the other Party's account now or in future.
5. Schwab shall act on the basis of the notarised joint instruction letter addressed to Schwab *vide* email dated 18 December 2025 by the Parties from the following email ids- zarir@zbharucha.com and niloufer.lam@gmail.com as also a Web Copy of this order emailed to it by either Party.
6. Parties authorise Schwab to forthwith act on the above notarised joint instruction letter.

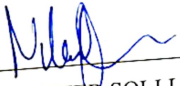
7. All Parties to act on a web-copy of this order.
