2. By this Writ Petition, the Petitioner seeks a direction to the Respondents to consider the Petitioner's representations dated 13/08/2024, 28/08/2024, 04/10/2024 and 19/06/2025 seeking S. T. Bus Stops on both sides of the Pune Bangalore Highway, at Punawale, Taluka Mulshi, District Pune.
