**SECOND APPEAL NO. 358 OF 2025 WITH INTERIM
APPLICATION NO. 8898 OF 2025:**

1. Heard the learned Counsel for the parties.
2. The learned Counsel for the parties submit that, the parties have amicably resolved the dispute and Consent Terms have been executed, and in accordance with the Consent Terms, Demand Drafts have been delivered to the concerned Respondents by the Appellant.
3. The learned Counsel seek leave to tender the Consent Terms.

Leave granted.

Mr. Ritesh Bellara, the partner of APL Yashomangal Developers, the Appellant, is present through video conferencing, and Mahadeo Nalawade(R1), Sukhdeo Kamble(R3), Atish Mahajan(R5), Pratiksha Waman (Through Ashok Waman) (R6), Akash Mahali(R9), Vrushali Vilas Rane, the legal representative of Respondent No.11, and Rajendra Sawant (R14), are present before the Court.
