“In the said proceedings, in an Interim Application, maintenance of ***Rs. 20,000/- (Rupees Twenty Thousand Only) per month*** has been granted. As the said interim maintenance amount was not paid, the Applicant – wife has filed the recovery proceedings. The arrears as of now has gone up to ***Rs. 17,00,000/- (Rupees Seventeen Lacs Only)***”.

4. As also in the second line of para 4, it has been inadvertently typed as :-

“The Respondent – husband who is staying and working ***in Dubai is in arrears of Rs. 7,00,000/- (Rupees Seven Lacs Only)***”.

Instead of

“The Respondent – husband who is staying and working ***in Kuwait is in arrears of Rs. 17,00,000/- (Rupees Seventeen Lacs Only)***”.

5. Accordingly, the sentences mentioned in the Order dated 09.12.2025 be corrected as

“In the said proceedings, in an Interim Application, maintenance of ***Rs. 20,000/- (Rupees Twenty Thousand Only) per month*** has been granted. As the said interim maintenance amount was not paid, the Applicant – wife has filed the recovery proceedings. The arrears as of now has gone up to ***Rs. 17,00,000/- (Rupees Seventeen Lacs Only)***”.

instead of

“In the said proceedings, in an Interim Application, maintenance of ***Rs. 25,000/- (Rupees Twenty Five Thousand Only) per month*** has been granted. And

“The Respondent – husband who is staying and working ***in Kuwait is in arrears of Rs. 17,00,000/- (Rupees Seventeen Lacs Only)***”

Instead of

“The Respondent – husband who is staying and working ***in Dubai is in arrears of Rs. 7,00,000/- (Rupees Seven Lacs Only)***”

6. Accordingly, the Order dated 09.12.2025, shall stand corrected as above. Rest of the order to remain as it is.
