INTERIM APPLICATION NO. 11011 OF 2025 AND
INTERIM APPLICATION (ST) NO. 30130 OF 2025

1. Interim Application (St) No. 30130 of 2025 is not on board.

2. Respondent nos. 2 to 5 had filed Civil Application No. 662 of 2015 for adding them as party respondents. The application was allowed on 18th September 2018. However, amendment in the second appeal is not carried out.
