1. Ms. Sana Khan, learned Counsel appearing for the Petitioner and Mr. Irfan Ansari, learned Counsel appearing for Respondent No.1 state that the parties have settled the dispute and tenders the Consent Terms.

2. Petitioner No.1-Mohammed Sohail Salim Shaikh, Petitioner No.2-Mrs. Naseema Mohammed Muzaffaruddin Shaikh and Respondent No.1- Samreen Mohd. Sohail Salim Shaikh are personally present in the Court. The Consent Terms are signed by them. All of them state that the dispute between them is settled in

terms of the Consent Terms. All of them state that they have signed the Consent Terms. Consent Terms are also signed by the respective Advocates. Respective Advocates identify signatures of the Petitioners and the Respondent No.1 on the Consent Terms.
