1. This is an application for Anticipatory Bail.
2. The applicant is apprehending his arrest in Crime No. 204 of 2025 registered at Boriwali Police Station, for the offences

punishable under Sections 316(2) & 318(4) of Bharatiya Nyaya Sanhita, 2023.

3. The learned counsel for the applicant and learned counsel for the first informant jointly submit that the parties have amicably settled their dispute and tendered the consent terms to that effect, which are taken on record and marked as “X” for the purpose of identification. **CONSENT TERMS BETWEEN THE APPLICANT/INTERVENER
AND THE ORIGINAL APPLICANT**

1. The Intervener hereinabove do hereby agree and confirm that if the Anticipatory Bail Application presented by the original Applicant is allowed, she has got no objection in respect thereof however, the same shall be subject to the terms and conditions mentioned in the present Consent Terms and upon breach of the said consent terms, the said protection granted under the present Anticipatory Bail Application shall stand vacated and/or set aside automatically upon the information being given by Applicant/Intervener to the concerned police authorities.

2. It is agreed between the parties hereto that the original Applicant shall give his permanent address of residence/office to the Police Authorities along with his contact Mobile Number and shall not change the same without giving prior intimation to the Police authorities.

3. The original Applicant viz. Mr. Bharat K. Ramsane do hereby agree and confirm and undertake to this Hon'ble Court to pay a total sum

of Rs. 37,00,000/- (Rupees Thirty Seven Lacs only) to the Intervener viz. Ms. Sarita Sahdev Toraskar within a period of 6 months.

4. The original Applicant Mr. Bharat K. Ramsane further agree and confirm and undertake that he shall make the payment in respect of the said amount of Rs. 37,00,000/- (Rupees Thirty Seven Lacs only) within the period of Six months in three equal instalments to the Intervener viz. Ms. Sarita Sahdev Toraskar on or before 30th June, 2026. In failure to comply with the above undertaking, the said protection granted under the present Anticipatory Bail Application shall stand vacated and/or set aside automatically upon the information being given by Applicant/Intervener to the concerned police authorities.

5. The original Applicant Mr. Bharat K. Ramsane further agrees and confirms and undertakes that he shall not seek any extension of time of whatsoever period from this Hon'ble Court in paying the amount as mentioned in the paragraph no.4 of the present consent terms.

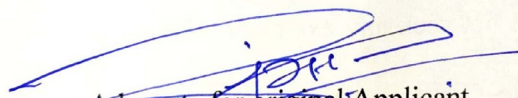
6. Subject to payment of the entire amount as mentioned hereinabove, the original Applicant i.e. Mr. Bharat K. Ramsane shall be entitled to file necessary Petition before this Hon'ble Court for quashing of the FIR being FIR No. 204 of 2025 registered under the provisions of Section

316(2), 318(4) of B.N.S. and accordingly, the Applicant/Intervener shall file necessary Affidavit giving her no objection for the purpose of quashing of the same.

7. All the statements made in the present consent terms shall be treated to be an undertaking given before this Hon'ble Court.

8. With this, the aforesaid Anticipatory Bail Application can be disposed of on such terms and conditions as this Hon'ble Court may deem fit and proper.

4. The parties are present in the Court. Considering the fact that the parties have settled their dispute which *prima-facie* appears to be of a civil nature, I am inclined to release the applicant on anticipatory bail. In the result, the following order is passed :

ORDER

- a) The Application is allowed.
- b) In the event of arrest of the applicant in connection with Crime No. 204 of 2025 registered at Boriwali Police Station, for the offences punishable under Sections 316(2) & 318(4) of Bharatiya Nyaya Sanhita, 2023, the applicant be released on bail on furnishing P.R. Bond in the sum of Rs. 25,000/- with one or two sureties in the like amount.
- c) The statements made in the consent terms are accepted as undertaking to this Court.
- d) In case of breach of consent terms, liberty is

granted to the first informant to file an application for cancellation of anticipatory bail granted by this order.

e) The interim application for intervention does not survive and the same is disposed of.
