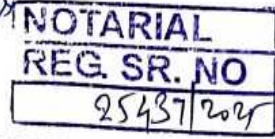

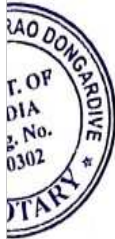
CONSENT TERMS

1. That, my Mother-in-law Mrs. Chanchalben Harilal Sanghavi, Executed her last Will on 23rd February, 2017. The deceased abovenamed died on 14th August, 2023 at Mumbai.

9. That, I voluntarily and unconditionally waive the requirement of service of citation upon me and consent to the grant of Letters of Administration in favor of the Petitioner without any further notice to me.
