) under the **Indian Succession Act 1925**. It is
) submitted that the parents of the deceased
) have predeceased the deceased. The deceased
) has no other Daughter or Son. Save and
) except as mentioned in para – 8, there are no
) other legal heirs left by the deceased. The Ld.
) Advocate for the Petitioner submits that the
) delay in making present petition is on account
)

) of the fact that petitioner was unaware of
) obtaining any legal representation. Now

) representation, Hence this Hon'ble Court in the
