) pre-deceased the Deceased. The Deceased left
) his wife, son and daughter. Save and except as

) mentioned in para – 9, there are no other legal
) heirs left by the deceased. The Ld. Advocate
) for the Petitioner submits that the delay in
) making present petition is on account of the
