- 1.** Heard Mr. Wani, learned Advocate for Petitioner.
- 2.** Present Misc. Petition is filed by Petitioner for issuance of legal heirship certificate under Section 2 of Bombay Regulation VIII of 1827 in respect of the properties and credits of deceased Devidas Kashinath Jethe alias D.K. Jethe alias D.K. Jetha. The names and details of legal heirs of the deceased are stated in paragraph No.4 of the Petition. Purpose for filing the present Petition is stated in paragraph No.6 of the Petition. I have perused the same.
- 3.** Consent affidavits dated 12.10.2024 of Ramdas Kashinath Jethe, Sunita Krishan Sharma and Anita Ajit Loke the legal heirs are filed on record and appended at page No. 36,40,44 of Petition.

4. In view of the above, there can be no impediment in allowing the Petition. Misc. Petition is allowed and disposed of in terms of prayer clauses 'a' and 'b' which read thus:-

“a) This Hon’ble Court be pleased to issue a Legal Heirship Certificate to the petitioner under the provision of Bombay Regulation VIII of 1827 certifying that follows persons i.e. (1) Ramdas Kashinath Jethe (brother), (2) Neelam Krishna Parab (sister), (3) Sunita Krishna Sharma (sister) and (4) Anita Ajit Loke (sister) are the only legal heirs of the deceased abovenamed i.e., Devidas Kashinath Jethe alias D.K. Jethe alias D.K. Jethe.”

5. Issuance of proclamation stands dispensed with.

6. Department is directed to issue the legal heirship certificate as directed above within a period of 3 weeks from today positively.

7. Misc. Petition is allowed and disposed subject to compliance of office objections, if any, forthwith which shall be allowed by the Department.
