5. Heard. The Ld. Advocate for the Applicant submits that the deceased died as spinster and the Applicant is not aware of the existence of heirs of the deceased. She further submits that the Applicant had enquired with various friends and acquaintances about the whereabouts of legal heirs of deceased but none of them are aware of any of the legal heirs. She therefore prays that the Chamber Order be allowed.

6. For the reasons stated in Affidavit dated 21st December, 2024 annexed to the Chamber order and averment made in Para-8 of the Petition, the Chamber Order is allowed. The Applicant is directed to publish the Citation in two newspapers viz. (1) “Free Press Journal” in English and (2) “The Parsi Times” in Gujarati language, within four weeks from the date of uploading the order. Office is directed to issue fresh Citation, if required.

7. Applicant to file Affidavit annexing therewith the newspapers within two weeks once, the publication is done.
