) further stated that Jitendra Hiralal Dekhtawala,
) brother-in-law of the deceased had also
) predeceased on 29.03.2020 and the parents and
) grand parents of the husband of the deceased are
) also predeceased the deceased. The Applicants

) have further stated that they are not in contact and
) not aware of the residential address of one of the
) legal heir Mr. Naresh Hiralal Dekhtawala. The
) Applicants have, therefore, requested to permit
) them to serve the Citation upon upon Naresh
) Hiralal Dekhtawala. brother-in-law of the deceased
) by way of substituted service by publishing in two
