1. In both the Interim Applications in the two Suits, the
Applicant/Plaintiff is seeking leave to produce documents listed at
Exhibit H (Interim Application No.1825 of 2025) and at Exhibit I
(Interim Application No.1896 of 2025).

2. Although a reply has been filed on behalf of the Respondent / Defendant, however, today when the matter is called out, Mr. Joshua D'Souza, learned Counsel for the Respondent / Defendant, submits that he has no objection if the two Interim Applications are allowed.

3. Accordingly, having heard the learned Counsel and having considered the submissions, the Interim Applications are allowed in terms of prayer clause (a) which read thus :
