2. Interim Application (L) No.31588 of 2024 & Interim

3. The Writ Petitions were dismissed for non-removal of office objections. The Petitions were at a pre-notice stage and on a lodging stamp number. Delay, ranging between 170-180 days, is caused in filing these Interim Applications.

Since all the Petitions were on a lodging stamp number at a pre-notice stage and since the delay is neither deliberate nor inordinate, **all the Interim Applications stand partly allowed.** Delay stands condoned on a condition of depositing an amount of Rs. 3,000/- per Petition.
