- 2.** Present Misc. Petition is filed by Petitioner for issuance of legal heirship certificate under Section 2 of Bombay Regulation VIII of 1827 in respect of the properties and credits of deceased Vasundhara Vasudev Dalvi alias Dalvi Vasundhara alias V. "a' This Hon'ble Court be pleased to issue a Legal Heirship Certificate to the Petitioner under the provisions of Bombay Regulation VIII of 1827 certifying that (1) Rajendra Vasudev Dalvi (2) Sanjay Vasudev Dalvi (3) Sandhya Satish Madav (4) Pallavi Pradeep Parab (5) Anjali Krishnakant Patekar (6) Gayatri Uday Sawant and (7) Sanika Sandeep Tawde, as mentioned in para no.4 herein above, are the only heirs and legal representatives of the deceased."

5. Issuance of proclamation stands dispensed with.

6. Department is directed to issue the legal heirship certificate as directed above within a period of 3 weeks from today positively.

7. Misc. Petition is allowed and disposed subject to compliance of office objections, if any, forthwith which shall be allowed by the Department.
