report has reported that the premises was found to be locked and unoccupied at the time of service, and upon making further inquiries with a neighbour residing on the 1st floor of the same building, as well as with the security personnel of the building, the Bailiff was informed that Mr. Krushnakant Eknath Waikar had been residing at the mentioned premises on a rental basis, but had vacated the property approximately three months prior to the attempted service. The neighbour and security of building further confirmed that they were unaware of Mr. Krushnakant Eknath Waikar's current whereabouts or any information regarding his new address. The Applicant, therefore requested to permit her to publish the Citation in the Newspapers viz. "Free Press Journal" in English language and in "Navshakti" in vernacular language i.e. Marathi.

4. Perused Para-9 of the Petition, it is mentioned and confirmed that the averment made in the Affidavit in respect of the addresses not known to the Petitioner.
