) Additional Affidavit dated 19.05.2025. It is stated in the  
) Affidavit that the husband and parents of the husband  
) of the deceased have predeceased the deceased.  
) Deceased died as widow. It is stated in the Additional  
) Affidavit that the applicant had made further enquiry  
) with the common friend and relatives regarding present  
) address and whereabouts of Suresh Ramkrishna Shetty
